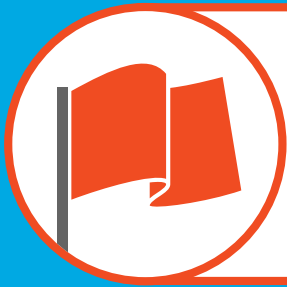
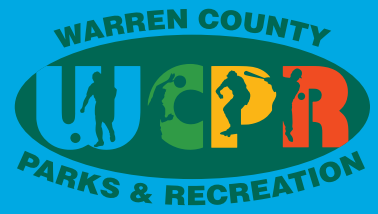


# RIVER SAFETY FLAG SYSTEM



## RED FLAG: HIGH HAZARD • ACCESS CLOSED

Ground conditions at Phil Moore Park or Romanza Johnson Park are not able to handle vehicle traffic, and access points are closed. River gauge CFS reading stage levels are 1501 and over. National Weather Service has issued a special advisory, watch, or warning for areas that could affect river conditions.



## YELLOW FLAG: MEDIUM HAZARD • USE CAUTION

River gauge CFS reading stage levels are between 301 and 1500. Water conditions will be swift, boaters will need to utilize extreme caution when canoeing or kayaking on the water way and should be aware of changing water conditions. Ground conditions at Phil Moore Park and Romanza Johnson Park are wet, and vehicle traffic should use caution while parking and driving to and from access points. Patrons should park only in designated areas.



## GREEN FLAG: LOW HAZARD • CALM CONDITIONS

River gauge CFS reading stage levels are under 300. Boaters should use caution while on the river and should remain aware of changing water conditions.

\*This system does not take the place of state river gauge readings, National Weather Service Warnings/Advisories, Special Weather Statements or other public safety agencies. The sole intent of this program is to help give both experienced and novice river recreational enthusiasts a better/visual/on site cue of information about park ground, river access, and river conditions.
